

Complaints with Navghar Police, Mulund, Mumbai :

1. My complaint to Mulund Police Senior Inspector was made on 10th April 2017, copies forwarded to ACP and DCP.

I had complained that drugs were sold illegally at Maruti Nursing Home, Mulund East and that drug Rokfos (ingredient Zoledronic acid) sold illegally caused "Grievous Hurt" within the meaning of section 320 of the IPC. There were serious side effects leading to death of my wife.

2. On 12th May 2017, I was called to Navghar police station for recording my statement to effect an arrest. My statement was recorded. However on 23rd May, 2017, I was informed that my complaint was not registered.

3. In the meantime, my RTI appeal was heard by DCP-Zone VII, Shri Sachin Patil who ordered an enquiry and asked the officers to send the complaint to Directorate of Health Services, Mantralaya, Government of Maharashtra.

This action was to determine whether the offence at Maruti Nursing Home was cognizable warranting arrest.

I told the writer that I will not sign in haste and that I will send the entire complaint along with evidence documents in English.

I sent an Email dated 12/12/2017 not to send the complaint themselves as I have to complete the file.

Still they sent the matter to Public Health Department. Navghar Police sent their complaint to the Directorate of Health Services, Arogya Bhavan, Mantralaya, Government of Maharashtra vide letter dated 25th December 2017 (Letter no.8470/17).

4. I submitted my detailed complaint in English along with date-wise complete evidence on 9th January 2018 (Reference Inward No.369, section 3) to the Directorate of Health Services.

5. I received a letter dated 02/08/2018 from Directorate of Health Services, Public Health Department, Arogya Bhavan. I was asked to enquire with Navghar police regarding status of my complaint.

This letter from Directorate of Health Services was sent to me after seven months of my complaint dated January 2018 and sixteen months of my police complaint dated 10th April 2017 to Mulund Police. It was fifteen months subsequent to my complaint with the Prime Minister's Office –

PMOPG/E/2017/0299058 dated 25th May 2017 forwarded to Navghar Police on 11th August 2017.

6. Vide letter dated 27th August 2018, I had requested answers from Police Officer-in-charge of Navghar Police Station.
7. Navghar police informed me that my case has been handed over to a panel of three doctors instituted by the Dean of Sir J.J.Group of Hospitals, Mumbai for assessing criminality involved in death of my wife.
8. I sent an RTI request dated 29th August 2018 to Directorate of Health Services.
9. I sent an RTI request dated 29th August 2018 and asked for information from Navghar police station.

I received reply from Inspector Shri Vikas Bhujbal that the matter has been sent to the Dean of Sir J.J.Group of Hospitals.

10. Vide letter dated 14th September, 2018, I requested the Dean of Sir J.J.Group of Hospitals to allow me to present my case before the panel of three doctors. I explained in brief that death was caused by serious adverse drug reactions of injection Rokfos from Cipla Limited.

11. On 31st October 2018, I gave a letter addressed to the Dean of Sir J.J.Group of Hospitals and gave them copy of submissions made by Dr.Mihirgiri Goswami before the Maharashtra Medical Council in my case No.MMC/DC/26/2017. That Dr.Goswami has admitted that Rokfos did not suit the Complainant's wife and that he had immediately discontinued it.

12. On 31st October, I gave an RTI request for status of investigation into death of my wife for criminality involved.

13. On 13th May, 2019, I submitted Order (Judgement) passed by Maharashtra State Commission for medical negligence and deficiency in service against the doctors and hospitals to the police officer-in-charge of Navghar Police Station.

14. On 13th September 2019, I sent a RTI request to Directorate of Health Services for action taken in my complaint.

15. On 4th October 2019, I sent an RTI request to Directorate of Health Services asking him about report given by the panel of three doctors.

16. I received a reply dated 23/10/2019 to my RTI query from Sir J.J.Group of Hospitals :

- a) That the report has been given to the expert committee formed by the Order of Govt. of Maharashtra in January 2014.

- b) As it was confidential, they cannot give the complainant copy of the report.
- c) That they have no authority to give details to police station for framing charges against the accused to register an FIR.

17.I received a letter dated 24/11/2019 that the status of my police complaint is pending for expert opinion.
