<u>Subject</u>: Homicide of my wife, Late Smt Kamini Barkur; untimely, unnatural and merciless death. The doctors watched her sinking for 5 days at a stretch & later abandoned her to her fate which was death.

This was just to protect Cipla drug Rokfos causing Serious Fatal Adverse Drug Reactions (ADRs).

Human Rights Violation in its worst form in the largest democracy in the world by bribing & corrupting every authority in India by Cipla Limited. "INHUMAN"

Matter in National interest - Health and lives of the citizens.

1. **Joint Drugs Controller, Dr.S.Eswara Reddy** was arrested by the CBI in Biocon Biologics bribery case. He has since been suspended by the Health Ministry.

Dr.S.Eswara Reddy was involved in my wife's case also; against Cipla Limited. "Fake Joint Investigation" was organised by Dr.S.Eswara Reddy, Dr.P.B.N.Prasad (CDSCO), Mr.Somnath Basu (CDSCO) along with FDA Gr Mumbai & FDA Goa to silence an aggrieved senior citizen (myself) seeking justice in death of his wife.

Very next day after "Fake Investigation Report", letter was issued by FDA Goa Director to Cipla Limited that no action is taken against the company. This was one year after FDA Goa Director had warned Cipla Limited of Legal Action. Obviously, bribing was the reason for the sudden U-Turn by Director of Food and Drugs Administration, Government of Goa.

2. Lokpal of India - Complaint was made by me against Dr.S.Eswara Reddy, Dr.P.B.N.Prasad (Joint Drugs Controller), Shri Somnath Basu (Asst Drugs Controller), Shri Rajesh Bhushan (Health Secretary) & DCG(I), Dr.V.G.Somani with Anti-corruption Ombudsman, Lokpal of India. Lokpal of India (Full Bench) disposed of my complaint without looking into it & multiple lies in their Order.

- 3. Enclosed, please find my complaint with the Central Bureau of Investigation against criminal offenders; Cipla Limited, doctors and hospitals. Also against Public Servants colluding with criminal offenders viz CDSCO officers, FDA officers, officers in Public Health Departments, Government of Maharashtra, Deans & Professors of Government Medical colleges. Lokpal of India (full bench) as well as Lokayukta of Maharashtra, Justice V.M.Kanade are answerable before the CBI for protecting corrupt public servants.
- 4. Also enclosed is my complaint with National Human Rights Commission.
- 5. Please also find my complaint to the Hon'ble President, Madam Droupadi Murmu & seeking her appointment in the interest of citizens of the country.
- 6. Please also refer to my email dated 02nd August, 2022 to the Hon'ble President, Madam Droupadi Murmu, copies sent to all authorities including the Health Minister attaching documents relating to the full episode in death of my wife and malpractices by Cipla in nexus with doctors, CDSCO officers, FDA officers, public servants supported by the Lokpal of India & Lokayukta of Maharashtra, Justice V.M.Kanade.
- 7. The crux of the matter before the Health Minister is "Fake Joint Investigation" organised by Dr.S.Eswara Reddy (erstwhile Drugs Controller General of India). This is explained several times before the last email dated 02nd August 2022 to Hon'ble President of India.

8. Criminal offences by Cipla Limited:

- a) Cipla played with lives in nexus with doctors. Death of my wife was a consequence of Cipla drug Rokfos causing serious ADRs never seen before with Zoledronic acid, the ingredient of the injection. Cancer injection was administered as a "Trial" to cure "Stiff Neck" in a single day.
- b) USFDA warning to Cipla Limited exposes adulterated drugs manufactured at Goa facility where the fatal drug was manufactured.
- c) Cipla cared a damn for life lost in spite of repeated appeals by the aggrieved complainant to investigate their fatal drug.

- d) Cipla violated statutory guidelines; Schedule M of Drugs & Cosmetics Rules.
- e) Cipla deceived FDA Goa Director with false written statements;
 - Linked imaginary diseases on the innocent victim after their drug caused her unnatural, untimely & merciless death.
 - Linked imaginary treatment for the imaginary diseases.
 - Cipla lied to the complainant as well as FDA Director that they had reported the serious ADRs to FDA, PVPI and DCG(I).
 - Cipla pleaded ignorance of the law of the land relating to reporting of serious adverse drug reactions.
- f) Cipla bribed & corrupted CDSCO & FDA public servants comprehensively exposed in "Fake Joint Investigation" organised by CDSCO.
- g) "Right to Life" of my wife was cut short by Cipla Limited in nexus with doctors. Illegal Trial conducted with Cancer injection (to be given only once in a year even to bone cancer patients) administered for curing "Stiff Neck" in one day.
- h) "Right to Justice" denied by Cipla Limited to an aggrieved senior citizen by bribing and corrupting each and every regulatory and law enforcement authority viz FDA, CDSCO, Public Health Departments, Deans & Professors of Medical colleges.
- i) Fake Science, Fake Chemistry and Fake Medical Theses used to silence an aggrieved senior citizen.
- j) Not only was my wife killed mercilessly but I was taken for a ride for 8 years seeking Justice.
- 9. Role of pharma firms in allegedly bribing CDSCO officials is under CBI scanner. Alleged involvement of several pharmaceutical companies in bribing officials of Central Drugs Standard Control Organisation (CDSCO) through a conduit to get their files "processed favourably" has come under scanner of CBI, people aware of the matter told ET. Dr.S.Eswara Reddy has since been suspended by the Health Ministry.

- 10. Two Acts were abused due to bribing and corrupting by Cipla Limited.
- 1) Drugs & Cosmetics Act, 1940 and 2) Lokpal & Lokayuktas Act Where is Safety for the Citizens of Bharat Mata?

CDSCO is the National regulatory body for drugs in India. Drugs are approved by Drug Controllers working in CDSCO. FDA is the State Licensing Authority. If both FDA-CDSCO are in nexus with pharma companies, where is the safety for the citizens? Since I had determined to persevere death of my wife, I could reach this stage with documentary evidence implicating all authorities.

- 11.NHRC (National Human Rights Commission) has been provided with full details of bribing and corrupting in every authority by Cipla Limited.
- 12. **United Nations Human Rights Council –** Since Pharma companies export their drugs to several countries across the world, I have tried to complain to UNHRC.
- 13. **Media** Cipla Limited silenced journalists in the media investigating "Cipla Drug Trial". I have emails and WhatsApp Chats from six of them.
- 14.All evidence is before all authorities including two Orders in Civil Suits (Maharashtra Medical Council and Maharashtra State Commission) implicating Cipla drug Rokfos causing serious ADRs leading to death.
- **15.CDSCO letter dated 17/01/2022 from Drugs Controller General of India** to FDA Goa Director to take action against Cipla Limited is proof that Cipla should have been prosecuted in **2018 itself.**
- 16.Criminal offenders viz Cipla Ltd, doctors and hospitals as well as civil servants involved in colluding with them including Lokayukta of Maharashtra, Justice V.M.Kanade as also Lokpal of India should be arrested by the Central Bureau of Investigation (CBI).

They have to face charges of "criminal conspiracy, cheating, to influence a public servant by corrupt or illegal means & bribery" among other charges. Serious antinational criminal activities amounting to Sedition deserving imprisonment for Life.

- Cipla Limited has destroyed the social fabric of our society.
- 17. My PRAYERS before the Hon'ble Health Minister:
 - a) Suspension of Dr.P.B.N.Prasad for his collusion in "Fake Joint Investigation".

b) Suspension of Mr.Somnath Basu (Assistant Drugs Controller of India) for

taking the aggrieved complainant for a ride for four years using Fake

Investigation Report.

c) Suspension of Dr.V.G.Somani and Mr.Rajesh Bhushan for failing to act on

Fake Investigation Report as also Cabinet Secretariat Order to investigate

Cipla Drug Trial.

d) Notices be sent to Cipla Directors restraining their participation in Cipla

activities.

e) Notices should be sent by Cipla Directors to all stakeholders informing them

of criminal complaints under Drugs & Cosmetics Act, 1940 and Rules

thereof as well as under the IPC for culpable homicide.

f) Cipla licence should be suspended.
