Re: Stern warning to doctors - I was very fortunate to have come across your weekly social media address wherein you issued a stern warning to doctors saying that you would act against them if they prescribed unnecessary tests for commission. You said that they cannot treat patients as a commodity. That you were aware that some doctors had good relationship with drug companies.

Subject : Matter pertains to death of my wife from serious adverse drug reactions of Cipla **Cancer drug Rokfos administered as a Trial to cure Stiff Neck** in one day.

1. Police Complaint of year 2017 with Navghar Police, Mulund, Mumbai on the instructions of then DCP, Shri Sachin Patil was sent to Director, Health Services, Public Health Department, Government of Maharashtra in December 2017 to adjudicate criminality involved in death of my wife.
2. The matter after seven months was directed to Dean of Sir J.J.Group of Hospitals in August 2018. The Dean of the hospital appointed a panel of three doctors to submit their report on 'Tatkal' basis within a week which date was 5th September 2018.
3. My complaint with the erstwhile Lokayukta of Maharashtra, Justice Tahaliyani was taken up by him and he summoned officials of Directorate of Health Services, Government of Maharashtra. This was in March 2020. When I showed him reply to my RTI Query by the Dean's Office that "Expert Committee Report" could not be given to the complainant nor did they have any authority to ask Navghar Police to file FIR, he immediately understood there was **Foul Play**. He told me to tell the Dean that if he does not give Expert Committee Report, he will summon the Dean himself. Subsequently, Justice Tahaliyani's term was over.
4. **Complaint against Lokayukta of Maharashtra, Justice V.M.Kanade** - Attached is my complaint to Governor of Maharashtra, for dismissal of Lokayukta of Maharashtra, Justice V.M.Kanade for colluding with civil servants in Public

Health Departments of Mantralaya, Government of Maharashtra, FDA Gr. Mumbai and the police department to dismiss homicide of my wife with false statements in his order dated 22.02.2022. That Justice V.M.Kanade should be made an accessory to homicide.

5. It is five years of my police complaint and DCP ordered the matter to be sent to Directorate of Health Services, Public Health Department, Mantralaya, government of Maharashtra.

FIR has not been registered in an "Open and Shut Homicide" suppressed with money power of an unscrupulous pharmaceutical company, Cipla Limited, playing with lives of innocent patients in nexus with unethical doctors with greed for money. "Bribes for Prescription" and "Prescription for Trials".

6. There are two judgements; one by the Maharashtra State Commission (Consumer Court) and the other by the Maharashtra Medical Council which has held doctors & hospitals; Maruti Nursing Home and Platinum Hospitals "Guilty" of causing death of my wife from serious Adverse Drug Reactions (ADRs) of injection Rokfos administered Ad Hoc without ascertaining indications of use and sold illegally at Maruti Nursing Home. The Order also exposes "False Death Certificate" issued by "Jupiter Hospital" to hush up the serious ADRs.

7. Cipla Limited, the manufacturer was informed by me on 16th August 2014 giving batch number, manufacturing date, expiry date to investigate, as death was drug-induced. As per Cipla "Authorised Representative", treating doctor of Maruti Nursing Home had informed them on 6th August 2014 of serious ADRs which caused death of my wife. Cipla took me for a ride for four years.

8. **In November 2017**, Ministry of Health & Family Welfare informed me; protocol to be followed in case of serious adverse drug reactions; Schedule 'M' of Drugs & Cosmetics Rules which mandated that the drugs be recalled and tested for "Standard Quality". Kingpin of Drug Racket, Cipla Limited was finally exposed. **Cipla violated the law in 2014.**

9. **FDA** (Food & Drugs Administration), Gr. Mumbai **violated the law in 2015** after my official complaint to them. Assistant Commissioner (Zone 4) with whom my

complaint was registered was subsequently arrested by ACB. FDA Gr.Mumbai, manipulated my complaint as received from a confidential source and filed a case before 15th Court, Mazgaon for illegal sale of drugs in 2015. **This case also has not been followed up for seven years.**

10. **FDA Goa** - Since FDA Gr.Mumbai refused to file case on adverse drug reactions, saying that the drug was manufactured in Goa, I filed my complaint with FDA Goa. FDA Goa Director warned of Legal Action but gave an opportunity for "Explanation". Cipla Head, Global Pharmacovigilance, linked imaginary diseases to my wife (Paralysis, spinal tuberculosis, bone tuberculosis) to imaginary treatment for the same without any evidence. Physician, Dr.Aafaque Dolare who had certified my wife as Fit for Surgery for cord compression (cause of stiff neck) had noted in in-patient records that my wife was "Pre-morbidly Healthy" "No Major illness in the past" "No known allergies" "No Addictions".

FDA Goa Director passed the matter to DCG(I) (Drugs Controller General of India - CDSCO) for action from his side. CDSCO is the National Regulatory Authority for Drugs in India.

11. **DCG(I) – CDSCO** – Drugs Controller General of India organised a **Bogus Joint Investigation with FDA Maharashtra** to silence the complainant seeking justice in unnatural, untimely and merciless death of his wife who was poisoned and left to die. The doctors watched my wife sinking to her death for five days just to hush up serious adverse reactions and protect Cipla Limited.

12. After Cipla was cornered, they told me on 26th June 2018 that they will comply with directions of the authorities as and when it comes.

Both the Authorities (FDA & CDSCO) were in Cipla's pockets as is proved from the enormous evidence collected by me. When law caught up with them, Cipla admitted to serious ADRs and finally officially reported to FDA, DCGI and PVPI.

13. Such a massive cover up by one and all regulatory and law enforcing authorities viz FDA Maharashtra and later FDA Goa, DCGI, CDSCO, IPC, MOHFW, Public Health Departments in government of Maharashtra, Dean and doctors of Sir J.J. Group of Hospitals.

14. Protectors of People; Lokpal of India and Lokayukta of Maharashtra have betrayed the people of India. Lokpal protected corrupted officers in Health Ministry for conducting a Fake Joint Investigation.
15. Lokayukta of Maharashtra had all evidence before him and was cornered by the complainant for misconduct in the last hearing held on 06.01.2022. He could not pass Minutes of the Hearing of 06.01.2022. Wrote an Order (meaningless) with 30 lies and chose to abandon his duty towards the people for which he is appointed. However, he is responsible as an accessory to this crime as follows :
- A) There are around 30 lies in his meaningless order which will be buried in Lokayukta office files.
 - B) Expert Committee Report was submitted in September 2018. Lokayukta, Justice Kanade protected the Dean and doctors of Sir J.J. Group of Hospitals for destroying evidence in a homicide case which is a serious criminal offence.
 - C) Further, allowed them to give a fresh report by lying that his predecessor, Justice Tahaliyani had asked the Dean to appoint an Expert Committee. Such blatant collusion in a homicide deserves severe punishment. Expert Committee was formed by the Dean of Sir J.J. Group of Hospitals on August 29, 2018. Whereas Justice Tahaliyani's hearing was held in March 2020.
 - D) Blood counts fell; WBC from 20,080 to 200 & platelets 143,000 to 20,000. They shifted my wife in a panic to perform surgery. There was hardly any blood left in her body. This was "**Attempt to Murder**" to hush up side-effects of Cipla drug. Lokayukta, Justice Kanade protected hard core criminal offenders. Also doctors & Dean of Sir J.J. Group of Hospitals.
 - E) Lokayukta has said that complainant had approached several competent authorities for death of his wife. He has to submit which authorities I have approached. Trying to silence an aggrieved senior citizen?
 - F) Lokayukta, Justice Kanade being a former judge of Bombay High Court has maligned the Judiciary with false Supreme Court Rulings explained in my complaint to the Governor of Maharashtra & Supreme Court of India.

16. This is not my battle but the winner will be the citizens of the country. The dangerous network between Pharma Companies-Doctors-FDA-CDSCO will be broken. Amendments to laws will be made after this network is prosecuted.

17. I request the Commissioner of Mumbai Police to take action ASAP. FIR has to be registered by Navghar Police.

Cipla Board of Directors, doctors and hospitals involved in playing with innocent lives have to be arrested. Hamied Family (Promoters of Cipla Limited) kept stakeholders in the dark regarding multiple crimes. Silenced journalists investigating Cipla Drug Trial. I have emails & WhatsApp Chats from several of them. This is threat to democracy. Cipla Bribed and Corrupted officers in FDA & CDSCO which amounts to Sedition.

18. Officers in Directorate of Health Services, Dean and other doctors of Sir J.J. Group of Hospitals, FDA/CDSCO Officers are involved in abetment to crimes against humanity, suppression and destruction of evidence in a homicide case.

19. Writ petition is before the Hon'ble Supreme Court of India in which all the above-mentioned parties are respondents.

20. Most importantly, Lokpal of India & Lokayukta of Maharashtra betrayal of the people is explained to the senior-most judges of the Supreme Court of India.

Request for fast action from your side. A senior citizen is being crushed and attempts to silence him is going on for the past 8 years.
