2. This was followed by:

Complaint to Union Health Minister – Suspension of officers in Health Ministry viz Dr.P.B.N.Prasad, Shri Somnath Basu, Dr.V.G.Somani & Shri Rajesh Bhushan. That Notices be issued to Cipla Directors, Noces to Cipla Stakeholders & Suspension of Cipla Licence.
 - b) Copy of my Complaint to NHRC dated **06th August 2022**.
 - c) Copy of complaint to Hon’ble President dated **06th August 2022**.
Criminal offences by Cipla Limited have been explained.
 - d) Copy of my complaint to Hon’ble President on New Drugs Bill dated **12th August 2022**.
 - e) Copy of my Complaint to Under Secretary (Drugs Regulation) dated **15th August 2022**. That New Drugs Bill is a FRAUD.
New Drugs Bill is a Prescription for Disaster. It serves the interests of the pharma industry, not public health.

3. Enclosed, please find my letter addressed to the Health Minister which is hard copy of my email addressed to the Health Minister, copies to relevant authorities. I have also enclosed the following:
 - a) My letter to NHRC dated 28th August 2022 on disposal of my complaint ILIMIE.
 - b) My letter to Lokpal of India dated 28th August 2022 on gimmick being played & tampering of evidence in a homicide case.
4. I have requested the Health Minister to handover the matter to the CBI at the earliest as I have submitted full facts with evidence documents to the CBI.
5. **Please note that I have not received acknowledgement for my complaints.**
6. Current letter is crucial for CBI to investigate CDSCO officers before they further damage health & lives of the citizens.
