- 1) Drugs sold without valid licence
- 2) Drugs causing "Grievous Hurt" and other side effects leading to death of my wife, Late Smt.Kamini Barkur

I wish to register a complaint with the Mulund Police station for the death of my wife due to illegal drugs sold.

I have filed a case in the Maharashtra State Consumer Disputes Redressal Commission for Medical Negligence and Deficiency in Service.

I have also filed complaints with FDA (Food and Drugs administration), Bandra Kurla Complex.

However I have now been advised legally that I need to also register a complaint with the Police Department. As such, I am giving brief facts of the case for your information.

Sequence of events leading to death of my wife Late Smt Kamini Barkur.

- a) She was first admitted to **Maruti Nursing Home** on 9th June 2014 for Stiff Neck and Cervical Spondylitis .
- b) Later shifted abruptly, in a panic, and in a very critical condition to **Platinum Hospitals** on 14th June, 2014 without any details of treatment and condition of the patient in the discharge card of Maruti Nursing Home.
- c) Finally she was shifted on 15th June, 2014 in a very critical condition to **Jupiter Lifeline Hospitals Ltd.** where she succumbed to her death on 24th June 2014.

I started my investigation into the death of my wife by following up with the doctors at Maruti Nursing Home who were involved in my wife's treatment and condition after 6 days - Dr.Mihirgiri Goswami (Owner of Maruti Nursing Home and orthopaedic under whose care

my wife was admitted), Dr.Aafaque Dolare (Physician who was called for certifying Surgical Fitness) and Dr.Satyen Mehta (Spine Surgeon, supposed to perform surgery).

In the course of my meetings with the doctors and also from my complaints to FDA, I have gathered two vital evidences viz.

- a) Drugs were sold illegally i.e without a valid licence required under the drugs and cosmetics act,1940 and
- b) Same drugs sold and administered to my wife caused "Grievous Hurt" within the meaning of section 320 of the IPC. No action was taken on the deteriorating condition of my wife for several days leading to her death.

* Proof that drugs were sold illegally is vide letter dated 28th January 2016 from FDA to me. I have attached copy of this letter.

* Proof that drugs caused dramatic reactions never seen before (as per the doctors themselves) is in the form of an Audio CD recording of meeting of doctors of Maruti Nursing Home with relatives of the deceased, submitted to the Consumer Court.

I will update you after the outcome of my case in the consumer court.

I hope that you will do whatever is possible and look into my complaint.
