Subject: Police Complaint of year 2017 with Navghar, Mulund, Mumbai Police in death of my wife from serious adverse drug reactions of Cipla cancer drug Rokfos administered as a trial to cure stiff neck in a single day.

Dear Sir,

This matter on the instructions of then DCP, Shri Sachin Patil was sent to Director, Health Services, Public Health Department, Government of Maharashtra in December 2017 to adjudicate criminality in death of my wife.

The matter after seven months was directed to Dean of Sir J.J.Group of Hospitals in August 2018.

The Dean of the hospital appointed a panel of three doctors to submit their report on 'Tatkal' basis within a week which date was 5th September 2018.

My complaint with the hon'ble Lokayukta of Maharashtra was taken up by him and he has summoned the Dean and officials of Directorate of Health Services and Directorate of D.M.E.R.

Attached is my correspondence with the hon'ble Lokayukta after the last hearing on 30th December 2020.

It is four years of my police complaint and three years after the DCP ordered the matter to be sent to D.H.S.

As is evident from my submissions, the report after being submitted by the "Expert Committee" has been destroyed or hidden by the Dean and the panel of doctors. The Dean and the Head of the panel Dr.Abdul Hannan have been misleading the hon'ble Lokayukta now as explained by me in my letter.

There are two judgements; one by the Maharashtra State Commission (Consumer Court) and the other by the Maharashtra Medical Council which has held doctors and hospitals of Maruti Nursing Home and Platinum Hospitals "Guilty" of causing death of my wife from serious Adverse Drug Reactions (ADRs) of injection Rokfos administered Ad Hoc without ascertaining indications of use and sold illegally at

Maruti Nursing Home. The Order exposes false Death Certificate issued by Jupiter

Hospital to hush up the serious ADRs.

Cipla Limited, the manufacturer was informed by me six and half years ago. They

took me for a ride for four years. When law caught up with them, they have

admitted to the serious ADRs and finally officially reported to FDA, DCGI and PVPI.

Such a massive cover up by the concerned authorities viz FDA Maharashtra and

later FDA Goa (the drug was manufactured in Goa), DCGI, IPC, DHS and now Dean

of Sir J.J. Group of Hospitals.

I have taken time to write this episode in the form of a book running into 29

chapters which has been given to all concerned people in both the State and

Central governments.

Cabinet secretariat and his team of six to seven deputies took time to go through

217 pages and approved the matter for action by the Health secretary.

I am sending this book to you to know malpractices and pharma-doctor nexus.

This is not my battle but the winner will be the citizens of the country. The nexus

will be broken as promised by the hon'ble PM with amendments to laws. I have

been repeatedly reminding him of this live example before the nation.

Finally, I request your good self to take action against Dean and other doctors

involved in abetment to crimes against humanity, suppression and destruction of

evidence in a homicide case.

FIR has to be registered and Cipla Board of Directors have to be questioned for

hiding this matter before the stakeholders, external auditors and regulators.

Hoping for fast action from your side. A senior citizen is being crushed and

attempts to silence him is going on for the past 6 ½ years.
